2. Reference is made to the Bid Form: Remove prior Bid Forms and replace with the attached new Revised Bid Form – Addendum 2. Revision is in the quantity of the 9.5mm Asphalt for Ridge Run, Laurel Lake Road, and Strawberry Lane.
3. Reference is made to Drawing 06-0001: Remove old drawing and replace with the attached new drawing. Revision is in the quantity of the 9.5mm Asphalt for Ridge Run, Laurel Lake Road, and Strawberry Lane.
4. A question was asked regarding verifying the quantity of Milling at 1.5" on the bid schedule is 684 SY. The response is Foxford Run is currently shown in the plans to receive only a surface course of 9.5mm asphalt because it currently does not have an asphalt surface course but only subgrade. It is our stance that the quantity for 1.5" mill should remain as it is currently depicted in the plans.
