



Liability Waiver & Hold Harmless Agreement

In consideration of being allowed to volunteer for the Town of Tyrone, Georgia (the "Town"), and The Downtown Development Authority of the Town of Tyrone, Georgia (the "DDA"), I (the undersigned) acknowledge that I am fully aware of the risks and hazards connected with the volunteering, including physical injury or even death, and I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or loss or damage to property owned by me, as a result of participation in volunteering for the Town or DDA.

I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, the Town, its elected and appointed officials and officers, servants, agents, and employees, and the DDA, its officers, servants, agents, and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in volunteer activities.

It is my expressed intent that this release and hold harmless agreement shall bind the members of my family, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, and COVENANT NOT TO SUE the above named RELEASEES. I hereby further agree that this Agreement shall be constructed in accordance with the laws of the State of Georgia.

In signing this release, I acknowledge and represent, that I have read the forgoing Liability Waiver and Hold Harmless Agreement, that I understand it, and that I sign it voluntarily as my own free act and deed; that no oral representations, statements or inducements, apart from the foregoing written agreements have been made; and that I EXECUTE THIS RELEASE FOR FULL, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY SAME.
